RPC Awarded Think Babies™ NC Micro Grant

For the third time in as many years, Randolph Partnership for Children has been awarded a Think Babies™ NC micro grant for \$2000.



The 2021 grant will be used to create an advocacy video that connects the dots between a strong economy and high quality early care and education. This will be a 2-minute video that will be shared with policymakers from mayors to the General Assembly to the US Congress.

Parents from our Family Engagement and Leadership Coalition as well as community partners from Randolph ChAMPS are involved in the planning and execution of this grant. The video will be completed by August 2021.

Tips for Businesses to Support Employees with Young Children

Nearly 70% of children under the age of 6 in Randolph County live in households where all the parents



work. And in North Carolina, infant-toddler child care is 38.4% of a single parent's income.

However, high quality, reliable child care is critical to supporting today's workforce, while at the same time growing the workforce of tomorrow.

So what can businesses do to help support staff who have young children as well as local child care providers (fellow small business owners and leaders)? Here are some no-cost investments business owners and leaders can make:

- 1. Survey employees and find out what their child care needs—and obstacles—are and how that impacts their work.
- 2. Offer flexible work schedules to accommodate family caregiving.
- 3. Educate employees about tax and subsidy eligibility for child care costs.
- Create Flexible Spending Accounts (FSAs) for employees to use (pretax) for child care costs.
- 5. Provide access to resource and referral services for child care to employees with young children.
